The Government of the Independent State of Samoa has received financing from the World Bank toward the Enhancing the Climate Resilience of the West Coast Road (CRWCR), and intends to apply part of the proceeds toward payments for civil works under the CRWCR Contract 1.1 - Rehabilitation of the West Coast Road, Package 1, Afega to Saina.

The Land Transport Authority ("LTA") now invites sealed bids from eligible bidders for the Rehabilitation of the West Coast Road. Bids are welcomed from Samoan and internationally based bidders and can be in currencies other than the Samoan tālā

The works generally shall consist of the following list of activities which is not exhaustive:

- Lot (2A) Afega to Faleula: Km 18.500 to 20.280;
  - Site clearance along the new road alignment including through easements.
  - Construction of the earthworks for the new road.
  - Construction of new stormwater drainage with associated catchpits, manholes, headwalls, and outfall drains, including outfalls through easements.

  - Construction of roadside surface water channels.
  - Construction of new road pavements and surfacing.
  - Construction of Sea Walls (Rock Revetment).
  - Installation of traffic signs.
  - Pavement markings.

- Lot (2B) Faleula to Puipa'a Km 20.280 to 22.100
  - Site clearance along the new road alignment including through easements.
  - Construction of the earthworks for the new road.
