<b>Reports to:</b>	Report to the Manager Procurement and Programming (PPD) on all matters relating to procurements, contract management and asset database management for Authority infrastructures in Samoa, ensuring that they are implemented in accordance with internationally comparable and LTA standards, objectives and targets.		

### Primary Objective

To implement and oversee the procurement, contract and asset management processes of the division and Authority ensuring that all projects commissioned by the LTA are carried out in accordance with standards required to meet its sanctioned objectives and targets. Also to ensure proper development and update of the asset management system in accordance with applicable international standards.

### Responsibilities

1	Oversee the operation and administration of Procurement processes, Contracts and Asset Management within the Programming and Procurement Division.
2	Provide advice to the Manager on all Procurement, Contracts and their management, and asset management activities of the LTA through the division's primary functions.
3	Supervises construction and maintenance works and report to Manager on a daily basis; liaise with contractor during progress of works.
4	Manage, delegate and coordinate tasks of the staff under the Procurement and Contracts, and Asset Management facets which report to him/her under direction of the Manager. This includes monitoring of the Authority's role as administrator of the road reserve, advising the Manager on any issues pertaining to this role.
5	Manage updates of the Asset Management system pertaining to road pavement and reserve maintenance including drainage construction, upgrades and maintenance linking all relevant documentation to the asset management system.
	Manage and supervise routine maintenance of the Traffic Signals network working with relevant LTA staff on road improvements pertaining to this infrastructure.
6	Coordinate with utilities, relevant LTA personnel and stakeholders during contract implementation and supervision phase.
7	Review and submit to CEO for approval through Manager PPD, Tenders Board reports, Tender submission results, Tender advertisements and relevant award documentation. For clearance by the Legal Division tender and contract documentation before the documents are used in the procurement process;
8	Ensure all contracts follow the required procurement processes which may include satisfying the requirements of the Samoa Tenders Board; Office of the Attorney General, Ministry of Finance, Ministry of Works, Transport and Infrastructure and Ministry of Natural Resources & Environment;
9	Plan, Monitor and Manage the procurement process to ensure projects are procured as efficiently as possible with minimal delays;
10	Assist Manager PPD in Preparing Financial budget for relevant budget required for related functions and duties under the position and for the division if required
11	To Manage consultants undertaking supervision, design and survey contracts pertaining to divisional and Authority systems and infrastructure, ensuring contract requirements are met in a timely manner.
12	Maintain and update the contracts register for budgeting, planning and reporting purposes to the Management, LTA Board, Minister, Cabinet, Parliament etc.
13	Participate and include subordinate staff in involvement with donor agency funded project implementation in capacity required.
14	Represent Manager PPD in internal committees and any other duties when required.
